To assure the consumer of quality and performance LED screw-in adaptors are rated by 2 agencies. "Energy Star" is a governmental body which rates and certifies such items as home appliances and high efficiency lighting. The "Design Lights Consortium" is a manufacturer's agency that tests and certifies LED lighting, most of which are applicable for commercial users.

Utilities require either of these certifications for all LED lights eligible for rebates. This requirement not only protects the consumer from inferior products, but also the utility from poor power quality.

- All lights must be installed in your residence in Crow Wing Power’s service territory.
- Return this Rebate Form and Required Materials before 12-31-19.
- Rebates are processed in 4-6 weeks upon receipt.
- Rebates are in the Form of a Credit Issued to Your Crow Wing Power Electric Account. No Cash Value.
