### BALANCING RELIABILITY AND COST: WHAT NEW GENERATION MEANS FOR CROW WING POWER MEMBERS

As a member of Basin Electric, Crow Wing Power depends on our wholesale power provider to deliver reliable electricity every day. One of Basin's most significant planned investments is the [Bison Generation Station](#), a natural gas-fueled facility that will serve as a cornerstone for long-term reliability. This new generation project is part of a broader effort to meet increasing demand across the cooperative network.

This investment isn't just about infrastructure—it's about you. Each member plays a role in supporting a power supply system that is dependable during every season. More demand means more generation is needed, and those facilities come with higher costs than existing resources. Still, they're necessary to ensure we can power your home, farm, or business with the reliability you've come to expect.

Recently, COO Eric Quale and I attended the Basin Electric Member Managers' meeting, where we heard initial figures related to a wholesale rate increase in 2026. Managers from across the region voiced their concerns, and Basin leadership listened. The Basin board will make final decisions at their next board meeting, with final adjustment announcements expected at their Annual Meeting in mid-August.



Several factors are driving this potential increase: new planning reserve requirements from the Southwest Power Pool (SPP) to ensure adequate power supply, rising maintenance costs, and the need for Basin to strengthen its financial position with higher margins to maintain favorable credit ratings. All of this is in addition to the long-term investment in generation like Bison.

Crow Wing Power remains actively engaged with Basin Electric through regular communication, participation in key meetings, and by contributing to their annual load forecasting process—an essential part of long-term energy planning. Additionally, our district representative serves as the Chair of Basin's Board of Directors, ensuring that our Cooperative has a strong voice in decisions that influence the power we provide to our members. Here at home, our Board and staff have recently completed strategic

planning and are in the early stages of our budget process and rate study. While we can't say exactly how these wholesale changes will impact local rates, we can say that adjustments will be necessary. We're doing everything we can to absorb as much of the rising costs as possible and will continue evaluating every part of our operation to make the most responsible decisions for our members.

We're committed to keeping you informed, advocating for the best

outcomes possible, and delivering the safe, reliable service you expect from your Cooperative.



